## Objectives

Students build the required skills to analyze international policies and strategies, apply multidisciplinary approaches and develop well-grounded recommendations in response to today's economic, political and social challenges.

## Who should apply?

This program is intended for students holding a bachelor's degree or an equivalent qualification. It is open to students from the ICP's Bachelor's in Social Sciences (International Affairs & Political Science track; Economics & Management track), as well as to students from programs in political science, economics and management, law, languages, history, and geography. It is designed for students who wish to combine academic excellence with professional development, in preparation for careers with national and international scope.

## Skills Acquired

By the end of the master's program, students will be able to:

- Understand and analyze the dynamics of global governance and

contemporary international challenges.

- Apply key concepts and major theories in International Relations, Political Science, Economics and Management.
- Rigorously assess the impact of public and private policies and strategic decision-making processes.
- Formulate constructive recommendations and strategies in international contexts.
- Become proficient in research methodologies and analytical tools to conduct academic studies or professional analyses.

## LANGUAGE REQUIREMENTS

As this master's program is taught entirely in English, applicants must demonstrate a minimum B2+ level (CEFR), with test results obtained within the two years prior to the application date.

### Accepted tests:

- IELTS ≥ 6.5,
- TOEFL iBT ≥ 90,
- Duolingo ≥ 110

### Exemptions:

- Native English speakers
- Prior studies with ≥ 70 % in English.



## CAREER PROSPECTS

This program prepares students for careers in international security, trade, international project management, risk management, and public affairs. It prepares students for roles such as analyst, consultant, project officer/manager, or policy adviser. It also provides a strong foundation for pursuing research and doctoral studies in the fields of Social Sciences, Economics or Political science.

INTERNSHIPS

Internships in Year 1 M1 (3-4 months) and Year 2 M2 (4-6 months) enable students to apply their skills and strengthen their employability.

INTERNATIONAL EXCHANGES & GAP YEAR

International mobility opportunities are available in M2. A gap year may also be considered between M1 and M2.

MASTER'S DISSERTATION

Oral defense of a master's dissertation, where students apply analytical and methodological skills developed throughout the program.

ACADEMIC STAFF

The teaching staff brings together experienced faculty specializing in International Relations, Political Science, Economics and Management, combining academic rigor with professional expertise to prepare students for internationally oriented careers.

VALIDATION

The program awards 120 ECTS credits over two years (30 ECTS per semester). An official M1 transcript is issued at the end of the first year and the master's degree is awarded upon successful completion of the M2.
